Subject: Regarding recruitment for the post of Registrar

Regional Centre for Biotechnology vide Advt. No. RCB/01/2023/Recruitment/HR dt. 01.11.2023, invited online applications for filling-up ONE post of Registrar (01-UR) in pay level 13 of Pay Matrix as per 7th CPC.

The Shortlisting Committee has scrutinized the applications of the applicants in the light of Prescribed Educational and other qualifications required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria were mentioned in the advertisement:

Essential:

Direct Recruitment: a) A post-graduate degree in any discipline. b) Minimum 15 years' experience in academic administration in a university or an educational institution imparting tertiary education. c) At least 5 years' regular service in a position carrying GP of Rs. 7600 or 8 years' service in a position carrying GP of Rs. 6600. d) The candidate must have strong oral and written communication skills. e) Must have knowledge of modern academic management practices and use of computers.

Deputation/Contract: Officers from the Central / State Governments/ Universities/ R&D Institutions, or PSUs, holding analogous post, or with at least 5 years' service in posts with Pay Level-12 or its equivalent possessing educational qualification and experience as prescribed for direct recruitment above.

The Committee carefully scrutinized all the received applications based on the above QRs and also considered the requisite administrative experience in an academic institution imparting tertiary education. Based on the criteria mentioned above, 10 applicants have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled.

Verification of documents will be done at later stage in the Selection process. If it is found that applicant has furnished false or wrong information, his/her candidature will be rejected at any time/ any stage.
