NOTICE INVITING QUOTATION

Sealed quotations are invited in single bid, from Original Manufacture/ Authorized Distributors of LED Panel light on behalf of the Executive Director, Regional Centre for Biotechnology, for the supply of LED Luminaire fixtures, as per schedule of supply and General terms & conditions.

01. Name of supply: Supply of LED Luminaires Fixtures for Regional

02. Estimated annual cost : Rs 2.08 Lac

03. Earnest money : Rs. 5000/-

04. Last date of sale of tender : 19.05.2017 up to 1400 Hrs.

05. Last date of receipt of tender : 19.05.17 up to 1500 Hrs

06. Date of opening of the tender : 19.05.17 up to 1530 Hrs

07. Time of completion of job : 30 days from date of issue of Supply Order

08. Pre-qualification criteria:

- (a) The bidder should be Original Manufacturer/ Authorized Distributors of LED Panel light of GEARUP/Pharox/FERRETERRO Lighting/Phillips/Crompton Delhi-NCR region and bidder must submit the copy of OEM Certificate/ Authorized Distributor certificate.
- (b) The bidder must have completed successfully, supply of LED Panel Lights of total value not less than Rs 1 Lac against one supply order to Govt Department/ State Govt/ PSU or Autonomous Body.

Attested copies of the Completion Certificates of supply issued by the Executive Engineer or above/head of department where supplies have been made, are required to be enclosed with the bid. On short fall of any document/ demand drafts (EMD), etc., the quotation will summarily be rejected and no correspondence will be entertained. Decision of the Competent Authority shall be final and binding in this regard.

The supplier should also furnish complete details of the concerned authority such as name with designation, valid address, telephone/ mobile number with STD Code, etc. supplier must submit definite proof from the appropriate authority, of having satisfactorily completed above said similar supplies, during the last two years, which shall be to the satisfaction of the Centre. The completed supplies will be open to inspection and in case supplies are not up to the standard, the consignment will summarily be rejected & no queries will be entertained in this regard.

(b) No subletting or sub-contracting of the supply will be permitted without the expressed consent of RCB authorities.

The envelops should be super-scribed clearly with Name of work and NIQ No, providing name(s) and postal address of the supplier with Phone/ Mobile/ Fax numbers and e-mail address if any.

The offer shall remain open for at least 60 days. Earnest Money Deposit (EMD) amounting to Rs.5000/- shall be accepted only in the form of Demand Draft drawn in favour of the Executive Director, RCB, payable at Faridabad and submitted along with the bid. Submission of EMD is mandatory and not exempted under any circumstances.

GENERAL TERMS AND CONDITIONS

Work: Supply of LED Luminaires Fixtures for Regional Centre for Biotechnology (RCB), 3rd Mile Stone, Faridabad-Gurgaon Expressway Faridabad

- 01. The supply shall be done as per schedule of items, specification terms and conditions and instruction of Engineer-in-charge on as and when required basis.
- The rates shall be inclusive of all taxes, duties and cartage.
- Quantities are indicative and the bidder is to inspect the site for estimating quantities as per site requirement. RCB reserves the right to issue orders under the contract, the cumulative value of which may vary from the estimated quantities. Supplier will have no objection for variation in quantities thereon. Payment will be as per actual supply executed.
- 04. The overall lowest bidder will be considered for award of work.
- 05. The Executive Director, RCB reserves the right to cancel any or all the tenders without assigning any reason.
- 06. Duly sealed quotation shall be dropped in the tender box placed at the reception counter of the RCB building
- 07. No escalation in any form either of materials or of labour shall be payable by the Centre.
- 08. All materials brought at site shall be got approved by the Engineer-in-charge before being used
- 09. No T & P shall be supplied by the Institute.
- 10. No advance payment shall be made.
- 11. EMD amount of successful bidder will be adjusted against Security Deposit, However EMD of unsuccessful bidder will be returned after finalization of tendering process.

- 12. Security deposit of 5% of each bill will be deducted and same will be released after successful expiry of defect liability of two years from date of completion of each supply.
- 13. The fixtures including choke (driver) shall stand on site warranty for a period of 02 years from the date of its final supply. Supplier has to replace the faulty light fixture with new one during the warranty period of two years from date of supply.
- 14. Time allowed for the supply shall be strictly followed otherwise the supplier shall be liable to pay compensation at the rate of 0.5% of the contract value of the job undone per week of delay on the part of the contractor subject to a maximum of 5% of the total contract value.

However, for any reason beyond the control of the supplier, the extension of time shall be granted upon application by the contractor in prescribed format. No claim for any compensation during the extended period shall be entertained and the centre's decision in this regard shall be final.

- 15. For proper completion of the supply, if any quantity variation or extra items are required, the supplier shall execute the same. Rates of extra items shall be derived from the tender itself as far as possible or else prevailing market rates shall be adopted.
- 16. In case the supplier resiles from the offer within the validity of tender or contractor fails to commence the work after issue of the award letter, the earnest money will be forfeited. On commencement of the contract, the amount of earnest money will be released after successful completion of the first supply under the contract.
- 17. Any claim dispute or difference arising out of or in connection with this agreement and which cannot be settled by mutual consultations, shall be referred to sole Arbitration or an Arbitrator to be appointed by mutual consultations. The award of the Arbitrator shall be final and binding between the parties to this agreement. The Arbitrator proceeding shall be governed by the Arbitration and conciliation ordinance dated 26th March, 1996 and shall be conducted in Delhi.

The agreement drawn shall be subjected to the jurisdiction of the courts at Delhi.
