- 1. Earnest Money Deposit (EMD) amounting to Rs 10,000/- In the form of Demand Draft drawn in favor of the Executive Director RCB, payable at Faridabad shall be submitted along with the bid without which the tender will be summarily rejected.
- 2. The Supply shall be done as per specification, terms & conditions and as per the instruction of the Engineer- in-Charge.
- 3. The tenderers may visit the site and assess the scope of works before submitting their offer.
- 4. Duly sealed tenders shall be dropped in the tender box placed at the reception counter of the RCB.
