The Institution

Regional Centre for Biotechnology (RCB) is an institution of national importance, created by an Act of Parliament, established by Government of India through the Department of Biotechnology (DBT) under the auspices of UNESCO. RCB has emerged as a pioneering institute for research in Biotechnology and is defining new horizons in providing world-class education, training and research at the interface of multiple disciplines for the benefit of mankind.

RCB has a strong commitment to exploring new frontiers, furthering science and connecting revolutionary areas of Biotechnology through cutting-edge research. The Centre boasts of the state-of-the-art research laboratories at par with the global standards. Its Advanced Technology Platform Centre (ATPC) is a highly sophisticated instrumentation facility comprising of high throughput technology platforms such as Genomics, Proteomics, Mass Spectrometry, Microscopy platforms including Electron Microscopy and Super Resolution Confocal Microscopy, Molecular Interaction, and the Animal Experimentation Platforms. RCB is also establishing a Bio-incubator in association with BIRAC that links promising research outcomes to commercialization by nurturing technology development in the broad area of biopharmaceuticals.

The Doctoral Degree Program

The Centre offers a doctoral program leading to the award of the PhD degree to students holding a post-graduate degree (or an equivalent) in any field of Science, medicine, or technology. The selected students are required to undergo a course work followed by research leading to a doctoral thesis under the mentorship of its faculty. The program is suited to candidates having interest to work at the interface of multiple disciplines in the areas related (but not limited) to structural systems, synthetic and chemical biology, virology, plant biotechnology, molecular medicine, analysis of complex diseases, drug discovery strategies. Eligibility Criteria

- i. Qualifications: MSc/MTech in any branch of Life Sciences/Chemistry/MPharma/ MVSc/ MBBS or an equivalent degree.
- ii. Qualifying Marks: 60% aggregate score or equivalent grade in the qualifying degree examination (5% relaxation for SC/ST/OBC allowed as per the Gol norms).

- iii. No of seats: Twenty-Five (25)
- iv. Reservation of seats: As per the GoI guidelines.
- v. In addition to the above, candidates should have qualified any of the following examinations and hold a valid fellowship offer at the time of interview like.
 - Joint CSIR-UGC test for Junior Research Fellowship (CSIR/UGC JRF)
 - Innovation in science Pursuit for Inspired Research (DST-INSPIRE)
 - DBT Junior Research Fellowship (DBT-JRF)
 - ICMR Junior Research Fellowship (ICMR-JRF)
 - Any other nationally-competitive fellowship offered by the Government

Selection Process

The applications in online format as per link below and on submission of an application fee of Rs.500/-, received by the due date will be scrutinized for eligibility. Eligible candidates will be called for a written test followed by an interview of the short-listed candidates during **20-21 June 2019**.

Fellowship

The students admitted to the programme will have to avail the fellowship for which they have qualified as per the rules of the funding agency. RCB will have no financial liability regarding the same.

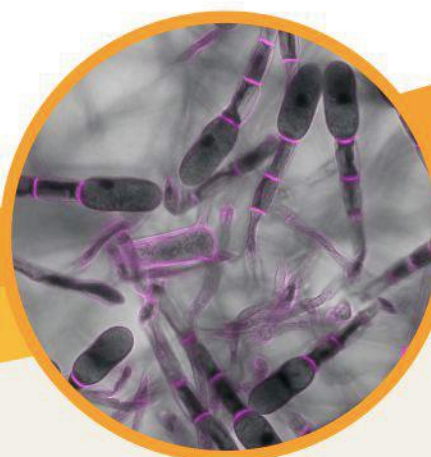
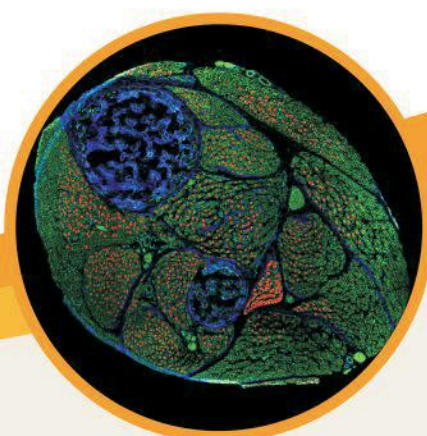
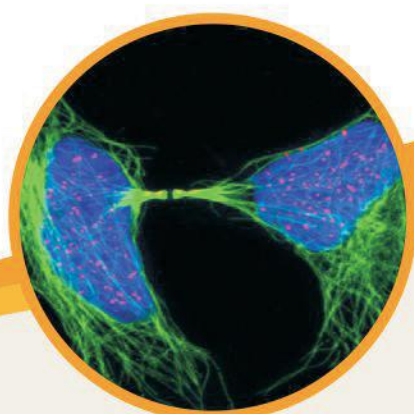

Eligibility

Regional Centre for Biotechnology (RCB) is an Institution of National Importance, created by an Act of Parliament, by Department of Biotechnology (DBT), Government of India, under the auspices of UNESCO.

Online applications are invited for admission to the PhD Program from applicants holding (or likely to complete by June 2019) MSc/MTech in any branch of Life Sciences/ MPharma/ MVSc/ MBBS or an equivalent degree with 60% marks (5% relaxation for SC/ST/OBC non-creamy layer/Differently-abled allowed as per the GoI norms) and having qualified a doctoral fellowship exam conducted by a government agency.

Selection Process

The qualifying criteria and selection process are as given on the website www.rcb.res.in. Shortlisted candidates will be called for written test and/or interview during 20-21 June 2019.

Last Date

The last date of filling up the online application is 30 May 2019.
